4. First-aid measures

5. Fire-fighting measures

Suitable extinguishing media: Use dry chemical, CO₂, water spray (fog) or foam.

6. Accidental release measures

Personal precautions: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Avoid breathing vapor or mist. Provide adequate ventilation. Methods and materials for containment and cleaning up: Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Use spark-proof tools and explosionproof equipment. Dispose of via a licensed waste disposal contractor.

7. Handling and storage

Precautions for safe handling: Put on appropriate personal protective equipment (see Section 8). Conditions for safe storage: Store in accordance with local regulations. Store in a segregated and approved area.
