SURFACE PREPARATION

Surface must be clean and thoroughly dry. Remove all mildew, dust, dirt, oil and grease with Passeport Élite Deck Cleaner. Rinse with clean water and allow to dry completely.

APPLICATION

Stir thoroughly. This product is of proper consistency as packaged to be applied without thinning under normal environmental and application conditions.

It can be applied uniformly with a bristle brush or lamb's wool short nap roller. Do not brush out excessively but remove any sags or runs before material has started to dry. On heavily stained areas a second coat may be necessary but should not be applied until final coat has completely dried.

LIMITATIONS

Remove all mildew before application. Surfaces to which primer is to be applied must be dry to touch. Do not apply on damp, humid or foggy days, when rain is imminent or in late afternoon when there is a threat of moisture condensing on the paint film. In hot weather do not apply material in direct sunlight, but work on the shady side of the structure if possible. Air and surface temperature should be 7°C (45°F) or higher during application and drying time. Do not mix with other paints, special thinners or water. Do not leave unfinished for a long period of time. The maximum period of time this primer can be exposed to weather prior to top coating is 60 days. Primers not top coated within 60 days should be power-washed prior to application of finish coats. STEINA Stain Blocking Primer is resistant to the deteriorating action of mildew. No claim is made for biocidal protection of other than the paint film. Do not apply to smooth side clapboards without thorough sanding, weathering or pressure washing.
