**STORAGE**

All **Passeport Élite epoxy and polyaspartic universal colorants** should be stored in dry places at temperatures between 12-28 °C. Do not expose them to freezing or excessive temperatures.

**MIXING**

Mix **Passport Elite universal epoxy and polyaspartic colorant** in 500ml for 2 minutes with each Part A (3.78L) of the product you want to add this colorant before adding Part B. Once the Part A mixture is homogeneous, pour in Part B of the product, respecting its volume ratio.

Clean with Xylene.
